

INTERVIEW (SRNA)

Authorities in BiH should introduce a series of measures to mitigate the negative effects of the coronavirus epidemic, including the abolition of parafiscal levies at all levels, and a reduction in electricity prices, said Branimir Muidza, president of the Foreign Investors Council in BiH. In an interview with Srna, Muidza states that the price of electricity should be lower by 20 percent, both for the economy and for the citizens of BiH, from April 1 this year to April 1 next year, or at least until the end of 2020, but also provide a real budget to help the economy, by reallocating budget funds...
