Dear members, partners, and friends,

Welcome to the pages of FIC News, edited versions of the FIC activities in period June - December 2019. In the second half of 2019, our work was focused on the preparation of a new edition of the White Book for 2020. Unique publication that detects specific business problems and proposes concrete solutions to them. By its content, the White Book has become guide to the governments in BiH, through the dynamic changes that the business environment in Bosnia and Herzegovina needs to undergo. It is high time that BiH, which is currently considered an underdeveloped nation, is transiting into a potential economically powerful state, which will align with the demands of global markets and take concrete steps to create better business conditions and more jobs, providing domestic and foreign companies with unparalleled opportunities for work and investment especially in service industry. Also, our existence in BiH and our continuous effort and work that has been focused for 13 years in the improvement of business environment, expressed through multiactivity approach, it's a proof that we are determined to provide any kind of assistance to the all level governments in BiH in implementing the measures of economic reforms with the necessary support of the international community, international and domestic organizations whose objectives are the same or similar to ours. The FIC, with the Chambers of Commerce in BIH, has conducted a series of expert discussions on the topics of education and employment

During the period from September 17 to November 12, 2019, the Foreign Investors Council in BIH successfully organized expert discussions on the topics of education and employment in three BIH cities of Sarajevo, Mostar and Banja Luka, in cooperation with the entity Chambers of Commerce and the Foreign Trade Chamber of Bosnia and Herzegovina. As an introduction to the public launch of the new, 7th edition of the White Book, scheduled for early next year, it was through these discussions that the Foreign Investors Council in BIH initiated a dialogue



between key stakeholders on the current state of affairs in BIH's labor markets, with a focus on the education system and the necessity of adapting it to the needs of the real sector and, above all, to the needs of investors. More than 30 representatives of the relevant institutions – ones in charge of labor, employment and education, including the entity ministries of labor and education, entity and cantonal employment offices, and representatives of the business and international community in BIH - participated in the held expert discussions.

Participants addressed the current problems with labor availability, with emphasis on the need for introducing more flexible forms of employment, the challenges of temporary and occasional employment in BIH, the lack of a legislative framework in this area, but also on the benefits that can be achieved through legal regulation of this area. Also, the participants touched on some other topical issues that companies face in the practical implementations of labor legislation, such as: sick pay and maternity leave, regulating part-time contracts, overtime and part-time work, employment regulation in the form of temporary agency work, etc. The discussions



were also held about the education system in BIH, about the preparation for work and the labor market, as well as about the ways in which the education system can adapt to the needs of the real sector, where some of the very successful examples of education of the existing and future workforce were mentioned. As a conclusion of this meeting, representatives of the public sector and relevant institutions readily accepted the recommendations of the business community, with the aim of implementing labor law reform as successfully as possible and with the ultimate goal of reducing unemployment and preventing the departure of young educated people abroad, as well as of meeting the needs of employers for a skilled workforce and solving employers' practical problems when it comes to labor-law relations.

FIC members given the "100 Greatest" awards - the best companies of BIH and the region have been declared



The "100 Biggest in BIH" project, with the *Poslovne novine* as its bearer, aims to show that there are very successful companies in BIH which are recognized both in the domestic and world markets, among which are some of the members of the FIC as well. The awards ceremony for the most successful companies, according to the business results accomplished in 2018, was held on September 18, 2019 in Sarajevo. **Holdina** ranked first in revenue in the large companies category, whereas **Kakanj Cement Factory** received the 1st place recognition in terms of revenue in the respected industry and the 20th place in net profit in the large companies category,

otherwise long-standing members of the FIC. The most successful company in terms of profit is the PE Highways of Federation of BIH, while the leading position for the largest exporters belongs to yet another one of our members, company **ArcelorMittal**. The event brought together over 450 of BIH's most prominent people that lead small, medium and large enterprises; all of which are ranked by the categories of total revenue, profit, export and cash flow investments.

The FIC held a meeting with the European Commission delegation



The FIC's Executive Director, Sanja Miović, and Zeraa Agriculture Investment company's Head of the Legal Department, Adnan Sarajlić, held a meeting with the European Commission delegation. The delegation consisted of representatives of the Directorate-General for Economic and Financial Affairs (DG ECFIN), the Directorate-General for European Neighbourhood Policy and Enlargement Negotiations (DG NEAR) and the Directorate-General for Labor and Employment (DG Employment). The purpose of this visit was preparing for the future evaluation of the Economic Reform Program

(ERP) of BIH 2020 - 2022. As a part of the slightly modified ERP evaluation procedure, prior to evaluation the European Commission identified - through its analysis and consultation with the key players in BIH - the main barriers to growth and competitiveness in the country and, from that point of view, also evaluates the structural reforms presented in the ERP. The aim of the visit was to meet with the representatives of foreign investors in BIH, them being the experts of the economic situation in the country. The meeting discussed preliminary defined obstacles to growth and competitiveness (with a focus on business registration, licensing, human resources and public enterprises), as well as the expected activities in the future with regards to addressing them, in order for the future ERP BIH assessment to be prepared as best as possible.

The FIC participated in the 'Fifth Sarajevo Arbitration Days' international conference

The International Arbitration Conference "Fifth Sarajevo Arbitration Days" on the topic of "Diversity of International Commercial Arbitration" was held on October 24, 2019 in Sarajevo. Besides the most up-to-date contemporary issues in the practice of international commercial arbitration, the conference covered topics such as the concession award system, FIDIC construction conditions, and the system of selecting arbitrators, or how to properly select an arbitrator in order to effectively resolve the dispute. Discussion on the challenges faced by women and other minorities in arbitration had also been opened. Sanja Miović, BIH Foreign Investors Council's Executive Director, stated that the investors in BIH are still referred to the local courts, not to arbitration, for the matters that regard disputes. According to her, the exceptions are the large companies that have an arbitration settlement clause in their contracts, but exclusively outside of BIH. It was concluded that there is still work to be done in BIH in so far as raising awareness of the benefits of arbitration with the business community and with lawyers, as well as ways for conducting it are considered. It was pointed out that the "Fifth Sarajevo Arbitration Days" will provide a platform for discussing issues of public interest in the field of construction projects with international and nationally recognized experts in the field.

The FIC participated in the press conference on the start of application of qualified electronic certificates in BIH

On behalf of the invitation by the Deputy Minister of Communications and Transport of Bosnia and Herzegovina, Mr. Saša Dalipagić, the Team Leader of the FIC Working Group for the ICT Sector and Member of the Board of Directors of the FIC, Mrs. Lana Sarajlić, has participated in a media conference on the start of the application of qualified electronic certificates in BIH, which was held on October 17, 2019 in Sarajevo. The establishment of the Office for Supervision and Accreditation of Certification Authorities in the Ministry of Communications and Transport of BIH in January 2018 created the necessary conditions for the implementation of the Law on Electronic Signature of Bosnia and Herzegovina. At the request of the public and private sector to obtain certification status, and after numerous activities carried out in this regard, the Ministry has accredited and entered the records of the first verifier of qualified electronic certificates, which created all the conditions for the practical application of qualified electronic signature in Bosnia and Herzegovina. This represents a significant step forward in the process of Bosnia and Herzegovina's progress towards the European Union, as well as in the realization of its European future. Recognizing the importance and interest of the Foreign Investors Council in



Bosnia and Herzegovina in the process of implementation of the Law on Electronic Signature of BIH, our representatives have been invited to participate in a press conference where they were able to highlight the achievements made so far, as well as the continuation of cooperation between the Ministry of Communications and Transport of Bosnia and Herzegovina and the Foreign Investors Council in the next activities in this area.

The FIC co-organized the Second annual SME Support Conference



The Second annual "How to Better Support the Development of Small and Medium-Sized Enterprises in BiH" Conference was held on November 20, 2019 in the Foreign Trade Chamber of BiH in Sarajevo. The conference was co-organized by the **Ministry of Foreign Trade and Economic Relations of BiH, the Foreign Trade Chamber of BiH, the BiH Foreign Investors Council and Eda - the Enterprise Development Agency**, with the support of the Swedish International Development Cooperation Agency (Sida) through the Swedish Embassy. The conference introduced a new framework for support of the SME development in the country, aligned with the European framework on the

one hand, and facilitating the harmonization of strategies and support policies for the SME's development within Bosnia and Herzegovina, on the other. The framework is built with the joint work of the teams of the Ministry of Foreign Trade and Economic Relations of BiH, the Federal Ministry of Development, Entrepreneurship and Crafts, the RS Ministry of Economy and Entrepreneurship and the BD Department for Economic Development, Sport and Culture. The finalization and implementation of this framework will enable significantly more intensive, better focused and systematically coordinated and organized domestic and international support for the development of SMEs in the country. The program and content of the conference was diverse and set up to bring the perspectives of the private and public sectors closer together, as well as key international donors and projects that support economic development. All participants of the conference were able to contribute with their experience, opinions and suggestions to the creation of a more effective and comprehensive support for the development of the SMEs. The conference was also attended by the representatives of the Delegation of the European Union, the Embassy of the Kingdom of the Netherlands, the Federal ministries, the Government of the Brčko District and other relevant institutions, as well as by the representatives of the private and NGO sectors.

Meeting held by the FIC's Working Group on Taxation and Fiscal Policy

Members of the Permanent Working Group on Taxation and Fiscal Policy, which operates at the FIC, held a meeting on October 4, 2019 to discuss the announced adoption of a set of tax laws in FBIH (Law on Income Tax, Law on Contributions, Law on Accounting and Auditing) which, according to the announcements from the FBIH Government, aim towards tax relief for the business sector. On the meeting, amendments were adopted by the FBIH Government on the proposals of the laws, the most important changes of which compared to the existing legal solutions are reflected in the following:


- The proposal for a Contribution Law provides for a reduction of the cumulative contribution rate from the existing 41.5% to 32.5%. Unique contribution rates were determined as follows: contribution for PIO 18%, health contribution 13.5% and unemployment contribution 1%.
- The proposal of the Income Tax Act stipulates that the amount of 800 Convertible Marks is non-taxable, while the income over this amount is taxed at 13%. Dividend tax 10%.
- With the proposal of the Law on Accounting and Auditing, the minimum tariff is abolished and abolished is the obligation of making a list in the case of price changes.

Considering the above legal changes, the members of the FIC Working Group on Taxes took the view that it was necessary for the new Income Tax Law to provide for a single tax rate, and accepted the amendments prepared by the FBIH Government, which predict for a single rate for income tax from 13% and a dividend tax of 10%. At the meeting, the members of the Working Group also said that they fully support the comments made by the Federation of Employers of FBIH, in terms of the need for the Government to ensure the continuity of reduction of contribution rates in line with the growth of public revenues, and to adopt amendments to the Income Tax Law in parallel with these laws, which will allow for a tax deduction for reinvestment.

Removed an obstacle related to dividend payment in FBiH

The Foreign Investors Council has asked the Federal Ministry of Finance for a final position, regarding the earlier opinion of the Ministry according to which the foreign founder of a company must open a non-resident account with a bank in BiH in order for the subsidiary company to pay him a dividend. Although this opinion of the Ministry is not binding, in practice it has caused many problems and has led to unequal treatment of banks. Some banks acted in accordance with the opinion and insisted that the foreign founder must open a non-resident account, while other banks accepted payment of dividends directly abroad, in foreign currency, as has been the practice in recent years. A letter sent by the FIC to the Ministry emphasized that the Article 3 of the FBiH Foreign Exchange Law stipulates that residents and non-residents use foreign currencies for payment abroad, while the Article 4 stipulates that payment, collection, transfer and payment in the Federation between residents, between residents and non-residents and between non-residents is made in Convertible Marks. These provisions of the Act indicate that only for the purposes of doing business between residents and non-residents in the Federation, the non-resident must have an open non-resident account in Convertible Marks. Therefore, only if he operates in the territory of the Federation the non-resident must transact through a non-resident account, and opening a non-resident account can by no means be a condition (limitation) for the payment of a dividend to the founder. For the sake of noting it, there is no similar requirement in the Republika Srpska in regards to the need of opening a non-resident founder's dividend payment account, which makes this issue even more challenging since the foreign exchange regulations in both entities are almost identical. In addition, the Law on Foreign Direct Investment Policy in BiH and the Law on Foreign Investment in the Federation of BiH stipulates that foreign investors have the right to transfer abroad, freely and without delay, in free convertible currency, the profits resulting from their investment in the Federation of BiH, including but not limited to: (a) profits from investments made in the form of profits, dividends, interest and other forms; b) funds acquired by investors after partial or complete liquidation of their investments or from sale. These transactions are made through commercial banks upon fulfillment of all tax and other statutory obligations based on public revenues in Bosnia and Herzegovina. On the basis of the above-mentioned FIC's initiative, the Ministry, in order to eliminate this legal uncertainty, has taken the final view that a domestic legal entity, which is a dividend payer, may make a direct transfer of funds on the basis of a dividend payment to a non-resident founder to his account in the country of residence.



The FIC at the "It's time for reforms: more efficiency in resolving economic disputes in BiH and better access to justice" conference

The FIC's Executive Director, Sanja Miović, participated in a conference held on December 12, 2019, as a part of the implementation of the Technical Assistance Project for Strengthening the Economic Judiciary in Bosnia and Herzegovina: **Improving the Business Climate through Faster Business Dispute Resolution**. The World Bank is the bearer of this project, which is being implemented with the financial support of the Government of the United Kingdom, in close cooperation with the High Judicial and Prosecutorial Council of BiH. The aim of the project is to support the BiH institutions to implement reforms that will improve the efficiency of commercial dispute resolution and access to justice. The purpose of the conference was to present analytical reports, produced within the project, to the representatives of the judicial and business community, governments, civil society and development partners in BiH. Specifically, the conference presented major findings and proposals of reform measures for: improving the access to justice for micro, small and medium-sized enterprises (MSMEs); faster resolution of low value disputes, implementation of process reforms to eliminate inefficiencies and bottlenecks in resolving cases; and mitigating case load imbalances and addressing organizational issues that affect the performance of the courts.

The FIC supported the Summit of members of the Business Women Club of the Republika Srpska



On December 14, 2019, the first Summit of members of the Business Women Club of Republika Srpska (BWC RS) was held in Banja Luka. The Summit was also supported by the Foreign Investors Council in BiH, with the Council's Executive Director, Sanja Miović, preceding at the Summit. She emphasized the importance of business networking through this form of cooperation and recognized BWC RS as a unique network of women with proven professional success, which - with their practical and systematic approach - create a better environment for business

development. In addition to the Foreign Investors Council, the contribution to the BWC RS Summit and networking was given by the FIC member companies, **Messer and DM Drogerie markt**. At the Summit, BWC RS briefed members on the recently signed Memorandums of cooperation with the Ministry of Economy and Entrepreneurship of the Republika Srpska, and on future activities and projects. *"By pointing out the challenges that women in the business world face, the RS Business Women Club is committed to cooperation and exchange of ideas in different industries. Networking of women working in companies or developing businesses in their companies aims to contribute to creating a mechanism for partnering the business community of women from RS with women around the world"*, said Ruža Lukić, executive director of BWC RS. Club of Business Women (BWC) is an association of business women of the Republika Srpska, founded in May 2019. Organization of innovative and competent women in business. BWC RS works with a proactive and analytical approach to networking, strengthening and capacity building of business women of the Republika Srpska. BWC RS brings together about 200 members of companies, entrepreneurs, managers and women employed in the private, non-governmental and government sectors.

The Foreign Investors Council, Messer and Nelt donated New Year's packages for children and youth from socially disadvantaged populations

The FIC, together with the **Messer** company, has through its cooperation with the "Roma Brothers" Roma association donated New Year's packages to 90 toddlers from socially disadvantaged Roma families this year as well, which this association helps. The "Roma Brothers" association, based in Sarajevo, was founded in 1994 with the goal of helping socially disadvantaged Roma families. Currently, the association has 110 members and helps about 500 Roma families. As a part of the "Parcel for the smiles of Pazarić residents" initiative, launched by informal citizen groups and aimed at collecting parcels and other supplies for the residents of the Institute for the Care of Mentally Disabled Children and Youth Pazarić, **Nelt** donated 40 New Year's packages. The Institute currently has 339 residents. We would like to thank our members Messer and Nelt for their assistance in the implementation of these humanitarian actions.

The FIC held an urgent meeting with partners on the controversial application of the new International Financial Reporting Standard (IFRS 16 "Leases")

As of January 1, 2019, a new accounting standard - IFRS 16 - "Leases" has become mandatory in the FBiH, with the entry into force of the distinction between the recognition of financial and operating leases at a lessee. Lessees from different industries have faced the significant effects of applying the new standard in the form of an increase in the former rental cost, which now consists of depreciation and interest expense. The cost is much higher in the initial years of the lease. Considering the current provisions of the FBiH Profit Tax Act, depreciation is a recognized expense only in the case of taxpayer-owned assets. In this regard, since the beginning of the application of the standard, the FIC has insisted that the Federal Ministry of Finance, by urgent procedure,



proposes and initiates the necessary amendments to the provisions of the Income Tax Law in FBiH, which would regulate the tax treatment of depreciation of assets that will be found in the books of the lessee under the application of IFRS 16. Faced with a large number of requests to resolve this issue, not only by the FIC but also by other business associations, in December 2019 the Federal Ministry of

Finance amended the Rulebook on the implementation of the FBiH Profit Tax Law, which sought to resolve issues related to the application of IFRS 16 "Leases"; that is, the issue of tax recognition of depreciation expense for rental property. Since the aforementioned amendments to the Rulebook did not solve the problem, on the initiative of the Federation of Employers of the FBiH on December 27, 2019, a meeting was held at which other representatives of the associations and companies participated in addition to the Foreign Investors Council. At the meeting it was pointed out that the said Rulebook did not solve the problem of tax recognition of depreciation costs, since it is a legal matter, and that the amendment of Article 19 of the Law on Profit Tax defining this issue should be approached. It was concluded that, at the beginning of the new year, these organizations would prepare a joint initiative to amend the law and submit it to the Federal Ministry of Finance.

The FIC participated in consultations regarding the preparation of the Country Report for BIH

At the invitation of Krassimir Nikolov, Head of Department for European Integration, Political Affairs, Press and Information at the Delegation of the European Union to Bosnia and Herzegovina, representatives of the Foreign Investors Council participated in consultations related to the preparation of the new Country Report for BIH. The European Commission has initiated the preparation of its annual enlargement package, to be published in spring 2020, which will also include a Report on Bosnia and Herzegovina. The Country Report aims to assess the progress made in the European integration process (political and economic criteria and alignment with the EU legislation), since the publication of the European Commission's Opinion on May 29, 2019. In order to ensure a strong and interactive dialogue with stakeholders from Bosnia and Herzegovina in the process of preparing the Country Report for 2020, the Foreign Investors Council has been invited to consultations with the other representatives of the business community and civil society, which were held on December 6, 2019, from 9:00 am to 2:00 pm in the building of the EU Delegation in Sarajevo, Skenderija 3a, in accordance to the following timetable: This meeting discussed issues related to the most important negotiating chapters with the EU, namely: The right to start an enterprise and freedom of the provision of services; Right of the Business Societies; Energy sector; Taxation; Justice and Fundamental Rights. On this occasion, the FIC also sent written contributions which summarized the observations of foreign investors in BIH in the areas within the scope of the association of the Foreign Investors Council.

The FIC supported the first International Tax Conference, organized by the Fiscal Association - IFA in Bosnia and Herzegovina

Fiscal Association - IFA in Bosnia and Herzegovina organized the first International Tax Conference on the topic of "Current Trends in International Taxation - Impacts and Challenges for Developing Countries" in the period from 30th to 31st of October, in Sarajevo. Contemporary global trends over the last ten years have further highlighted problems in the economic development and international tax policy. The accelerated transformation of the world economy, fueled by globalization, growing tax competition and a large number of tax frauds and significant loss of tax revenues, and the pervasive digitization processes



that cause not only changes within current business models, but also strongly reflect on the work of tax administrations, questioning the simultaneous action and the validity of some of the basic institutes of international tax law, are just some of the trends in international taxation that concern both developed and developing countries alike. Although the tax problems of developing countries are longstanding and have long been recognized, the trends place new pressure on the legal and tax systems of these countries as well as on their economy. Bosnia and Herzegovina is no exception. A country with a complex constitutional structure, a multi-level but insufficiently generous tax system, and a complicated and often ineffective legal framework is facing these trends with an extra dose of concern. Participation of developing countries in international tax



discussions and arrangements is therefore of the utmost importance in order to provide adequate support in the face of the challenges ahead. Organizing this conference is one form of support - they pointed out from the IFA. The Conference sought to provide some answers to the upcoming trends. Special attention was paid to the following topics: Tax reforms in Bosnia and Herzegovina with the aim of reducing the tax burden on labor; Developing efficient, transparent, reliable and knowledge-based work by tax administrations as the backbone of

developing countries' tax systems; Implementation challenges of the new Multilateral convention for the implementation of measures to prevent the abuse of the agreement on the evasion of double taxation (MLI), developed within the OECD's BEPS project and which has been signed by more than 80 countries so far; Contemporary transfer pricing challenges, with a particular emphasis on the equipment and preparedness of the developing country tax administrations in regards to responding to this tax action; National and international challenges in tax procedures, with a focus on taxpayer rights issues, enhancement of tax transparency and new ways of resolving tax disputes; The challenges of taxing the digital economy, especially in the field of indirect taxes. The above topics were spread over panel discussions that lasted two days, where various tax experts had an opportunity to express their opinions, as well as practical experiences. The conference brought together eminent tax experts of the country and of the world. Recognizing the importance of such an event, the FIC, as a sponsor, supported the first International Tax Conference held in BIH. **Aleksandra Grubor**, director of the IT company **Saga NFG**, participated at the conference in front of the FIC.

The Government of the Canton of Sarajevo, in cooperation with the United Nations Development Program (UNDP) and the Ministry of Labor and Social Policy, the Employment Service of the Canton of Sarajevo, the Ministry of Economy and the Ministry of Education, begins with the Labor Market Analysis in the Canton of Sarajevo. The first activity in this process is the development of a situational analysis, after which the Action Plan for Employment in the Canton of Sarajevo will be approached to. In order to perform this analysis adequately, the stakeholders of this activity organized a series of meetings with the relevant stakeholders. In this process, the BIH Foreign Investors Council was recognized as one of the relevant actors and on this occasion a meeting was held in front of the FIC by its Executive Director Sanja Miović, Legal Affairs Coordinator Tea Kajan, Team Leader of the FIC Working Group on Education and Employment and member of the FIC Board, Ranko Markuš, and Muamer Halilbašić, a consultant and UNDP representative. At the meeting, the FIC representatives were introduced to the programs/activities of the Ministry of Labor and Social Policy of the Canton of Sarajevo, the Employment Service of the Canton of Sarajevo, the Ministry of Economy of the Canton of Sarajevo and the Ministry of Education of the Canton of Sarajevo. The participants of the meeting also discussed the key challenges of functioning of the labor market in the Canton of Sarajevo and about the proposals for improvement or correction of the existing programs and the initiation of new ones. The representatives of the FIC gave their views on the key challenges in the functioning of the labor market and the employment system in the FBiH and the Canton of Sarajevo, as well as suggested so as to how and to what extent the FIC can contribute in the implementation of the said program and the Action Plan for Employment, which will be the final result of mentioned activities.

The FIC participated in a consultative meeting of the ERSE Network

Legal Affairs Coordinator at the Foreign Investors Council, Tea Kajan, participated in a consultative meeting of the ERSE Network members (education, reform, security and livelihood). The aim of the network is to support the higher education reform by advocating the introduction of full-time student practice, which was formed as a part of the Faster to Work with Student Practice Program, funded by the European Union. The network is comprised out of representatives of the academic community, business community, student associations and civil society organizations with the aim of introducing full-time student internships, which aims towards contribution to a greater stay of, and employment for, young people in Bosnia and Herzegovina. The meeting was held on October 16, 2019 in Sarajevo, at which the project itself and its activities so far were presented, followed by an introduction to future activities and a discussion on how network members can become involved. At the meeting, the FIC representative Tea Kajan said that FIC is committed to supporting and engaging in all activities that aim at improvements of youth education and at an increase of employment in BIH. In particular, she emphasized the importance of such cross-sectoral cooperation, which is crucial in the fulfillment of these goals, and that the Council will formalize its membership of the ERSE network in the coming period so that it can actively participate in the implementation of all planned activities with the other members.

The FIC held a meeting with the representatives of the Czech Embassy in BIH

The Executive Director of the FIC, Sanja Miović, met with the new Head of the Trade and Economic Department of the Embassy of the Czech Republic in Sarajevo, Ondřej Pick and Mrs. Ines Terza. The topic of the meeting was the development and improvement of trade relations between companies from the Czech Republic and BIH; in particular, the provision of information on export opportunities, current market conditions in BIH, as well as the ability to find and initiate contacts with the BIH distributors and potential joint venture partners. The participants of the meeting also discussed about the new programs of support to the development of the BIH economy by the Government of the Czech Republic.

FIC NEWS

The FIC participated in the Economic Freedom Audit



On November 28, 2019, a unique event called "Economic Freedom Audit" was organized in Sarajevo, organized by the Multi Association and in a cooperation with the British Embassy, the Fraser Institute of Canada and other domestic and foreign partners. The aim of this conference is to bring together recognized experts that are working on the annual Economic Freedom of the World report, and to seek to identify key problems regarding the poor state of economic freedoms in Bosnia and Herzegovina. The event was attended by over 100 experts in the fields of economics, policy, business, academia and the international community, that define the social

trends in BIH. Tea Kajan, Legal Affairs Coordinator, participated in the conference in front of the Foreign Investors Council in BIH. She was also a panelist in a working session titled "Legal Structure and Security of Ownership Rights". Admir Čavalić, director of the Multi Association, has on behalf of the organizer said that this event marks



the beginning of lobbying processes aimed at the promotion of economic freedoms in BIH. Given the departure of the BIH workforce, the lack of higher rates of economic growth, as well as the decline of other economic indicators, it is clear that we are at a turning point - which way BIH wants to go, and that this conference offers an answer based on arguments, based on the experience of successful countries - which is that Bosnia and Herzegovina needs more economic freedoms for its citizens, businessmen, and for all those who wish it well. It is of utmost importance for Bosnia and Herzegovina to advance the state

of economic freedoms. The main reason for this is that it ranks 92nd on the current Index of Economic Freedoms. The shortcomings in terms of economic freedoms relate to the rule of law, which is also a common problem for other, formerly centralized-planning government economies of the region. Consequently, there is a negative impact on economic growth, foreign direct investments and the unemployment rate. The Economic Freedom Audit event will result in a White Book publication on the promotion of economic freedoms in BIH.

Members of the FIC Working Group on the Gray Economy held a meeting

On December 3, 2019, a meeting of the FIC Working Group on the Gray Economy was held in Sarajevo, at which the members of the Working Group established the 2020 Activity Plan. In addition, the members agreed that the existing draft section on the gray economy in the new White Book should be updated, because changes have occurred in certain areas since the finalization of this section up until today. The meeting also discussed the best way to promote the "Gray Economy" chapter in the new 7th edition of the White Book, whose publication is expected in early 2020, through expert discussions and roundtables, modeled on those already organized by the FIC, as a part of the implementation of recommendations from previous editions of the White Book. At the end of 2019, the Working Group on the Gray Economy was joined by the representatives of Nelt and Zeraa Agriculture Investment companies (Hepok and Bosnaplod), which are members of the BIH Foreign Investors Council as well.

Wpd Adria


Wpd Adria is a regional subsidiary of the German wpd, one of the pioneers in the use of renewable energy sources and the largest on-shore wind farm developer in Germany. Founded in 1996, the company currently operates in 25 countries and employs more than 2000 professionals. Wpd Adria has so far successfully implemented projects for four wind power plants in Croatia - Trtar Krtolin, Orlice, Katuni and Ponikve, with a total installed power of almost 100 MW. The company is constantly exploring new potential locations both in Croatia and in the surrounding countries, which includes Albania, Bosnia and Herzegovina, Montenegro, Kosovo, Macedonia, Slovenia and Serbia. In Bosnia and Herzegovina, the Velja Međa wind farm projects are active in the Ravno municipality and the Livno - Glamoč - Grahovo project system, which would be the largest wind park in Europe. In addition to wind farms, the possibility of carrying out hybrid projects in which the wind and sun energy or wind and water would be maximized is being explored. The realization of such projects in the long term contributes to the local self-government units, the electricity system and the increase in the share of production from OIE. Through its projects, wpd encourages the sustainable development of the community in which it operates, which is accomplished especially through donations aimed at children and young people, the conservation of natural and cultural heritage, and the development of organic agriculture. Through its work and investment in the use of renewable energy sources, wpd Adria aims to contribute to environmental protection and to the economic development of the region in which it operates. It also wants to contribute to the reduction of the carbon footprint, reduction of dependence on fossil fuels and to provide for clean energy that will underpin sustainable development.

Eastern Mining


Eastern Mining d.o.o. is a Bosnian research and development company, owned by Adriatic Metals, from United Kingdom. The primary objective of the company is focused on exploration and exploitation of mineral resources around Vareš municipality. The stated goal has potential not only for the growth of the company, but also a significant potential for the development and progress of the Municipality of Vareš, Zenica-Doboj Canton, and the state of Bosnia and Herzegovina. The activities of the company have been intensified in 2017, since more than 30 million Convertible Marks was invested in this project exclusively from the founders' funds. Eastern Mining is a concessionaire for the exploration and exploitation of metallic deposits of the former zinc, lead and barite mine Veovača and Rupica deposit. The two locations are 12km from each other, with the existing necessary infrastructure and in the immediate vicinity of the city of Vareš. Developed and budgeted exploration programs include drilling and testing, resource modeling, mining studies, as well as administration of exploration and exploitation fields, general administration and geological services. As of 2018, Eastern Mining has completed more than 30,000 meters of exploratory drilling, expanding the known area of mineralization, and defined some of the highest quality polymetallic interceptions globally. In cooperation with subcontractors and consultants, Eastern Mining currently employs around 100 people and cooperates with around 200 different suppliers in BIH. The company has obtained over 50 different approvals and permits so far. The focus of activities for 2020 will be aimed at further geological exploration, both in the existing concession area and in the wider regional area, with the aim of increasing confirmed ore reserves and of extending the lifetime of the new mine. According to the current plan, the opening of the mine and the start of production are planned for the year of 2022. The new plant will process 800,000 tons of ore annually, and will produce three types of concentrates that will be sent for further processing outside of BIH. Understanding the importance of social responsibility, in local cooperation with the Mining, Geology and Civil Engineering Faculty of Tuzla and the University of Zenica Institute, Eastern Mining supports many cultural and sporting events, activities and clubs, as well as individuals and institutions that contribute to the culture and to the potential of their community and Bosnia and Herzegovina.

Second Sustainable Business Report of Coca-Cola HBC B-H Sarajevo has been published

Celebrating the five decades since the start of distribution of Coca-Cola products on the market of Bosnia and Herzegovina, the Coca-Cola HBC B-H Sarajevo presented the Sustainable Business Report for 2018 to the public. The second local report presents the joint successes of Coca-Cola and the BIH society in the field of sustainability, related to achievements in energy resource management, water and waste recycling, support for community projects, environmental care, consumer and customer care, and employee engagement and training. Of the total 120 million liters of soft drinks that Coca-Cola HBC B-H imports or produces for the domestic market, 89% are produced in Bosnia and Herzegovina, and 68% of total purchases (at cost) in 2018 went to domestic suppliers. By meeting the goals of sustainable business, Coca-Cola HBC B-H seeks to continually reduce the direct environmental impact of its operations and the indirect impact that is manifested through the activities of suppliers and business partners. Thus, the amount of waste has been reduced by 55% since 2010; from the same year, water consumption was reduced by 52%, and over 95% of waste was recycled in 2018. The total amount of purified water discharged has decreased by 17.5% since 2014. Coca-Cola HBC B-H Sarajevo is particularly proud of having fulfilled one of the Group's 2025 sustainable business goals two years in advance: as of 2018, over 50% of refrigerators in the domestic market are energy efficient refrigeration units. Coca-Cola remains by far the most popular product of the company, albeit with a reduced share in the carbonated soft drink category over the last three years (falling from 63% in 2016 to 58% in 2018). This decrease is in line with the growing share of Coca-Cola Zero calorie drink, rising from just over 2% in 2016 to over 5.5% in 2018. With a focus on offering consumers as many desired products as possible, low-sugar and sugar-free options have been included, across categories and across a broader range of packaging, while providing clear and transparent information to consumers has enabled making informed choices. Progress can be noted in the reduction of the company's environmental footprint: energy consumption during production was reduced by 26%, 13% more waste was recycled, water consumption was reduced by 52%, 55% less waste was generated. In 2018, the production volume increased by 13% compared to 2017, while the percentage of used materials increased by 17%. EFT-Mine and Stanari Thermal Power Plant

This year, the production of 2,050 gigawatt hours of electricity



Savo Mirković, the director of "EFT-Mine and Stanari thermal power plant", said that the end of the business year is extremely favorable for the "Mine and thermal power plant Stanari", which has results above expectations, noting that more than 2,050 gigawatt hours of electricity are expected to be produced. *"11.5 million cubic meters of cover rocks have been exploited, while the plan was about eight million. Coal was planned at 2.620.000 cubic meters, whereas the production will be about 2.7 million. The plan for electricity production is 2.025 gigawatt hours, and we expect over 2,050*

gigawatt hours", Mirković told reporters after a ceremony that honored the company's most successful employees for achieving outstanding results this year. Mirković announced overhauls for the next year, namely a major overhaul of the generator, which is why a smaller delivery was planned, i.e. around 2,010 gigawatt hours of electricity. He added that he expects to employ 20 more workers in the next year in order to reach the number of about 880 employees, since 14 workers of various occupations, mostly craftsmen, left the "Mine and the thermal power plant Stanari" during the year. Mirković said that 12 workers were retiring, and that nine employees had been singled out for the results achieved, and they were awarded a total fund of 20,000 Convertible Marks. This year's first prize and a sum of 5,000 Convertible Marks was presented to Sava Pantić, the chief manager of coal and ash delivery. Pantić said that the award is a boost, adding that he has been working at the Stanari mine for 34 years. The cash prizes were presented by the "EFT Group" management representatives, at a formal lunch organized for the occasion of the company's outstanding results this year. This company, named "EFT-Mine and the Stanari thermal power plant", has been operating since January 2008, and as a socially responsible company, has been significantly involved in the social life of the Municipality of Stanari.

Record share of alternative fuels in the Lukavac Cement Factory

The Lukavac Cement Factory, known as a pioneer in the use of alternative fuels in BIH and beyond, is ending 2019 with a record 45% share of these fuels. 35,000 tons of waste fuel was consumed, reducing coal consumption by about 20,000 tons. This success of the Lukavac Cement Factory is the result of years of investments in new technologies, enabling that up to 70% of fossil fuels to be replaced by alternative energy sources in its plants. Increasing the share of alternative fuels brings many benefits not only to Lukavac Cement, but to the wider community as well. High energy costs are being reduced, the survival and future of the plant are being ensured and secure jobs are being created. Alternative fuel is the fuel of the future, a green alternative, the use of which significantly reduces carbon dioxide emissions into the atmosphere and creates many positive effects. *"Our cement factory is a serious partner of the circular economy, and any increase in the share of alternative fuels in our production represents an improvement in energy efficiency and environmental sustainability. We are proud of our results this year, we have produced 450,000 tons of cement and are ready for further planned investments for the period 2019-2020, that amount to 10 million Convertible Marks. In this way, we directly save fossil fuels, reduce acid emissions, and thus further improve the quality of our products and air in the city of Lukavac, as shown by the conducted measurements. We are technologically trained like the most modern European cement manufacturers are and we are fully ready to meet the strictest environmental requirements. Since December 12, we have stopped with the production due to the overhaul of the factory, which will last until March 2020"*, said Stjepan Kumrić, General Director of the Lukavac Cement Factory. Many new projects are launching at the beginning of Spring, followed by the continuation of the VISIT US action. During 2019, the factory hosted about 1000 visitors. With sincere thanks to all the guests so far, Lukavac Cement invites all interested institutions, schools, faculties and citizens to visit this successful BIH company.

TAX NEWS

Amendments to the Income Tax Law of the Republika Srpska

The "Official Gazette of Republika Srpska", No. 58/19 of July 9, 2019, promulgates the Law on Amendments to the Income Tax Law of the Republika Srpska. The most significant amendments to the Income Tax Law (hereinafter referred to as "the Law") relate to the following:

- the provision of Article 4, item 4) of the Law concerning taxpayers exempt from income tax liability has been amended, so that it now stipulates that the income tax is not paid by the legal entities registered for the performance of non-profit activities and which make profits: from budgets or public funds, from sponsorships or donations in cash or in kind, membership fees, as well as proceeds from the sale or transfer of goods, except the goods that are used or have been used to carry out activities on a commercial basis;
- it is prescribed that taxable income does not include income from collected written off receivables, which were included in the tax base in previous tax periods and were not recognized as an expenditure in the tax balance. In this way, the re-taxation of revenue from the collected written off receivables is avoided;
- impairment expense of inventories based on the reconciliation are recognized in the tax period in which those inventories are sold or written off under the conditions laid down in Article 11;
- the Law was supplemented by the new paragraph of Article 12a., stipulating that depreciation is recognized for investments made in fixed assets which are not owned by the taxpayer, provided that such investments increase the cost of the asset and do not reduce the rent defined in the lease agreement. This enables taxpayers to recognize the depreciation expense in the tax balance for investments made in other people's assets, under the prescribed conditions, since such investments fall on the taxpayer's expense and undoubtedly lead to an outflow of funds;
- the text of Article 14, paragraph 1 was amended with the words "and credit" in order to eliminate the confusion created in practice by the narrow interpretation of the term loan, so the addition of the proposed words was done to eliminate this misunderstanding and clearly stipulate that the accrued interest and associated costs of the loan and credit for performing the business activity are recognized at expense, provided that the amount of interest and associated costs is a liability of the tax year in which the deduction is made;
- Article 26 of the Law has been completely amended, and it is stipulated that a taxpayer who invests in equipment and facilities in the Republika Srpska for performing registered production activities is entitled to a reduction of the tax base for the value of the investment made. Other provisions related to this article are unchanged, which implies that this tax privilege applies to production activities determined by the decision of the Minister of Finance, that the equipment and facilities are directly used in the production or processing process, and that the tax base is reduced during the tax period. in which equipment and facilities are put to use for the full value of the investment made;
- Article 37 has been supplemented by a new paragraph 2, so that the tax year, in addition to the calendar year, may be determined differently in individual cases by decision of the Ministry of Finance;
- a part of Article 13, paragraph 2 of the Law has been deleted, with the aim of clearer regulation that the expenses of provisions are recognized in the period when they are used, provided they have been previously recognized in the income statement.

The Law shall enter into force on the eighth day after its publication in the "Official Gazette of the Republika Srpska", except for Article 8, which shall enter into force on January 1, 2020.

Amendments to the Rulebook on Implementation of the FBiH Income Tax Law

In the "Official Gazette of the FBiH", No. 94/19 of December 13, 2019, The Rules on Amendments to the Rulebook on the Implementation of the Income Tax Law (the "Rulebook") were published. The Rulebook entered into force on the day following its publication. The most significant amendments made by the Rulebook are:

- Paragraph (7) of Article 42, which regulated the recognition of depreciation expense on rented property in accordance with MRS 17, is deleted.

- In Article 62, which treats management, technical and educational services fees, they are limited to services between related parties referred to in Article 44, paragraph (3) of the Law, and services of installation or installation of equipment, technical support, training, consulting or other similar services provided by a non-resident as well as services provided electronically outside the territory of Bosnia and Herzegovina without the physical presence of persons in Bosnia and Herzegovina, are related exclusively to management, technical and educational services between related entities.
- In Article 93, a new paragraph (7) is added, according to which the beginning of using the tax deduction on the basis of employment must correspond to the period of commencement of work of newly recruited employees, and the word "obligation" throughout the article is replaced by the word "base" so that the established tax base is reduced for the amount of gross salary of newly employed employees and not, as previously prescribed, a tax liability.
- Article 107 specifies the determination of the position of the tax balance under ordinal numbers 64, 65 and 69.

ECONOMIC OVERVIEW FOR BIH

In focus

- ✓ The House of Representatives of the Parliamentary Assembly of Bosnia and Herzegovina confirmed Mr. Tegeltija as the new Chairman of the Council of Ministers, ending the long political blockade at the state level. Negotiations to form government at the federal level are still ongoing.
- ✓ The construction of Thermal Plant Tuzla - Block 7 and several new sections on the Corridor Vc are the assumption that the construction sector (together with private consumption) will be crucial in preventing the BIH economy from entering the negative area in 2020 due to external negative impacts.
- ✓ Lending difficulties have led the cumulative growth rate for industrial production to reach as high as - 5.6% in the January-October period, signaling the worst performance in industrial production history in BIH. Exports of goods also decreased in October by 5.2% in comparison to the last year, or 2.4% when looking at it from the beginning of the year. According to this, it is certain that exports of goods in 2019 will end in a negative area for the first time since the recession in 2012.
- ✓ The banking sector in BIH earned 328.2 million Convertible Marks in the third quarter of 2019, or 4.0% more than in Q3 2018. Moreover, this was the record high net worth value of the banking sector in its history (since Q3). The banking sector managed to suspend the NPL growth by 7.7%. The NPL ratio of household lending remained at 6.1% while the NPL ratio of corporate lending continued to decline (9.3%).
- ✓ The baseline scenario for the medium term remains unchanged. Economic growth is likely to remain modest by 2020, with GDP growth projections of 1.9% annually. In 2021, we expect stronger economic growth due to the forecast for economic momentum in the euro area, which will be outward oriented. Therefore, our target GDP rate for 2021 is 2.3% annually.
